### *Nobilis 3yr Reimbursed Warranty*

---

Prairie Wind PC's (hereinafter referred to as PWPC) warrants to the original purchaser that this Nobilis Computer will be free from defects in materials and workmanship for a period of three (3) years from the date of invoice. This warranty applies to the components comprising the computer, including: CPU, CPU fan, memory, hard drive, optical drive, keyboard, base unit, except batteries. Batteries are consumable items and are covered for one (1) year only. Monitors, scanners, speaker sets, external drives, backup media, power protection devices, and other external devices are covered under their respective manufacturer's warranties, not this warranty.

All component items not normally carried and offered for sale by PWPC or otherwise identified as "special order" or "non-stock" are covered under their respective manufacturer's warranties. PWPC will repair or replace, at the option of PWPC, any Equipment having a defect in material or workmanship. All replacement parts shall be provided by PWPC at no cost to customer. Circumstances may require the reloading of the operating system as onto the computer. Replacement parts are new or like-new (tested equivalent to new). PWPC may provide replacement parts made by various manufacturers when in its repair process. All replacement parts shall also be covered under this Warranty for the remainder of the Service Plan Period or thirty (30) days (whichever is longer).

PWPC warrants that replacement parts will be interchangeable with the parts they are to replace, and will conform to the specifications current when they are shipped. Some problems or defects may require PWPC or Customer to reformat or replace a hard disk drive. Under such circumstances all data on the disk drive may be lost. Customer is solely responsible for the security of data. PWPC shall not be liable for the loss or destruction of data or media resulting from a defect in materials or workmanship covered by this Warranty. PWPC strongly advises Customer/User to implement and maintain a regular routine to backup data to minimize the loss of data in the event of Equipment failure.

Customers that intend to keep a failed Hard Disk Drive to attempt data recovery or protect the data must make arrangements to purchase a replacement Hard Disk Drive prior to the service incident. PWPC will not accept the failed Hard Disk Drive after the service incident has been closed.

If hardware repair is required, PWPC will arrange, for next business day delivery, of replacement part(s) from the manufacturer. The cut-off time for next business day delivery is 2:00PM CST. PWPC will contact the Customer if extenuating circumstance prevents the shipment of replacement component(s) and offer the Customer a replacement solution to restore the Computer to factory ship conditions.

Physical damage, cosmetic damage and/or component failures that have, in the sole opinion of PWPC, occurred by accident, misuse, mishandling, misapplication, lack of proper maintenance, or act of God/Nature are not covered by this warranty.

This warranty is a limited warranty. As the sole remedy for a breach of this warranty, PWPC will at its discretion repair or replace defective component(s) with component(s) of equivalent or better performance.

PWPC IS NOT LIABLE AND SPECIFICALLY DISCLAIMS ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF A BREACH OF THIS WARRANTY OR FOR ANY SOFTWARE OR DATA THAT MAY BE LOST DUE TO HARDWARE FAILURE.

In order to take advantage of this warranty, the original purchaser must provide a valid proof of warranty purchase. Hardware additions, software not preinstalled by PWPC, upgrades, modifications, or configuration changes by the customer are not covered by this warranty.

EXCEPT FOR THE WARRANTIES SET FORTH HEREIN, PWPC DISCLAIMS ALL OTHER WARRANTIES EXPRESS OR IMPLIED INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ANY IMPLIED WARRANTIES THAT MAY BE IMPOSED BY APPLICABLE LAW ARE LIMITED TO THE DURATION OF THIS LIMITED WARRANTY.
